Voting results of the Extraordinary General Meeting of Shareholders of NC «KazMunayGas» JSC

National Company «KazMunayGas» JSC (hereinafter – «KMG» or the «Company») publishes the results of the voting of the Extraordinary General Meeting of Shareholders held on 6 November 2023 (hereinafter – «EGM»).

At the time of the EGM, the total number of voting shares of KMG amounted to 610,071,023. According to the registration log, as of 14:30 a.m. (Astana time) on 6 November 2023, Korotkov Ivan, an authorized representative of 2 (two) shareholders owning 544,883,639 common shares in total, which is 89.31% of the total number of voting shares of the Company, registered to participate in the EGM. Thus, in accordance with the requirements of paragraph 1 of Article 45 of the Law of the Republic of Kazakhstan «On Joint-Stock Companies», dated 13 May 2003 No. 415-II (hereinafter referred to as the Law), a quorum for the Meeting is provided, and the Meeting is recognized as competent to make decisions on the agenda of the EGM.

The notice of the EGM was published on 6 October 2023. Materials on the issues on the agenda of the were available in accordance with the established requirements. No questions on the materials of the EGM were received from shareholders within the established time frame.

A vote of shareholders was held on the issue included in the agenda of the EGM meeting and decisions were made.

On the composition of the Board of Directors of KMG

Following the results of the vote, Askar Orazalievich Shakirov was elected as a member of the Board of Directors of KMG (hereinafter - BoD) of KMG, an independent director.

Askar Shakirov has held the following positions for the last 3 years:

- since July 2021 Parliamentary Assembly Deputy Chairman of the Organization for Security and Co-operation in Europe (OSCE);
- from September 2019 to January 2023 Deputy Chairman of the Parliamentary Senate of the Republic of Kazakhstan;
- August 2019, reappinted from January to September 2023 Parliamentary Deputy of the Senate of the Republic of Kazakhstan, Chairman of the Committee on International

Relations, Defense and Security of the Parliamentary Senate of the Republic of Kazakhstan.

At the same time, Mr. Shakirov certifies that there is no information for disclosure specified in sub-paragraphs d), e), f) and g) of paragraph MDR 2.6 of Table 1 of the Appendix of the AIX Market Disclosure Rules of the AIX Business Rules.
