- ▲ KASE was established on November 17, 1993 under the name Kazakh Inter-bank Currency Exchange – two days after the Tenge (the national currency of Kazakhstan) was introduced
 - ▲ KASE is a commercial organization functioning in organizational-legal form of joint stock companies
 - ▲ KASE has 48 shareholders (as of 01.12.16) – banks, broker-dealer organizations, asset management companies and other financial institutions
 - ▲ Major shareholder: National Bank of Republic of Kazakhstan (50.1 %)

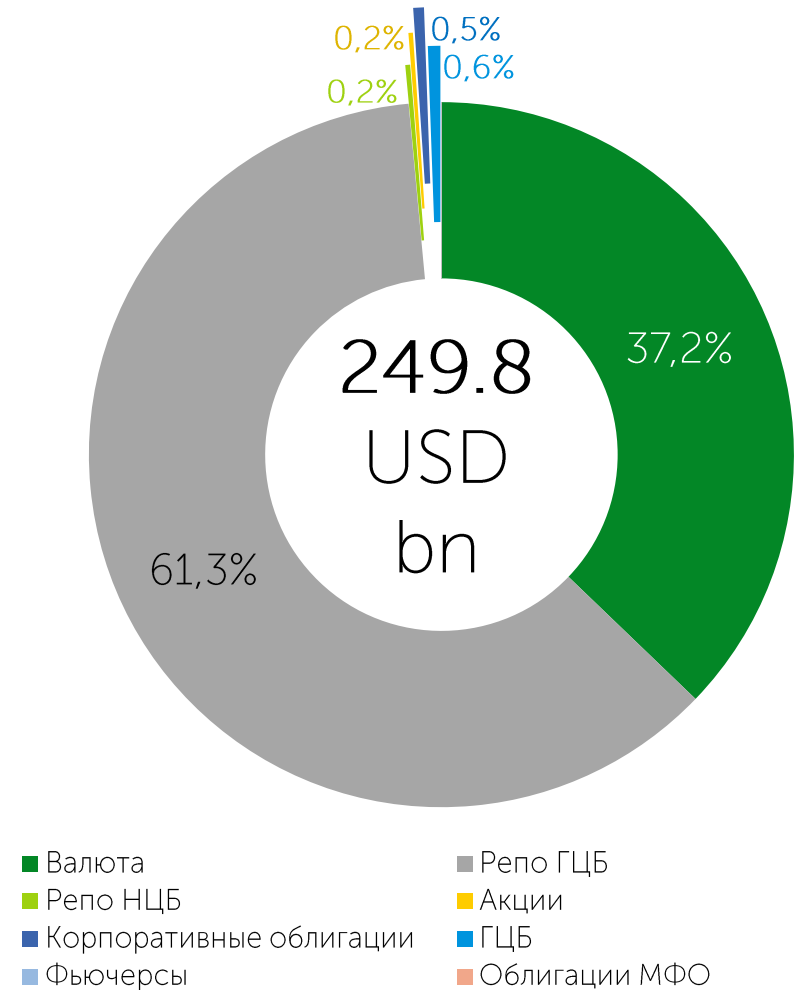

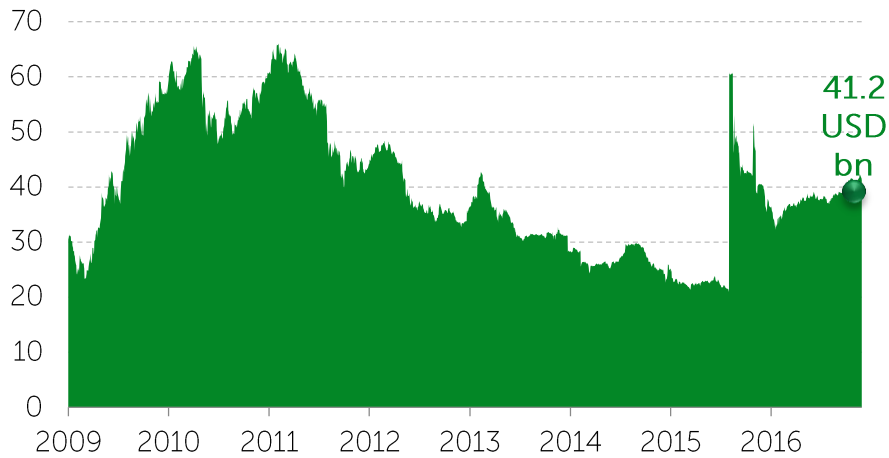


KASE Market Volume and Kazakhstan's GDP

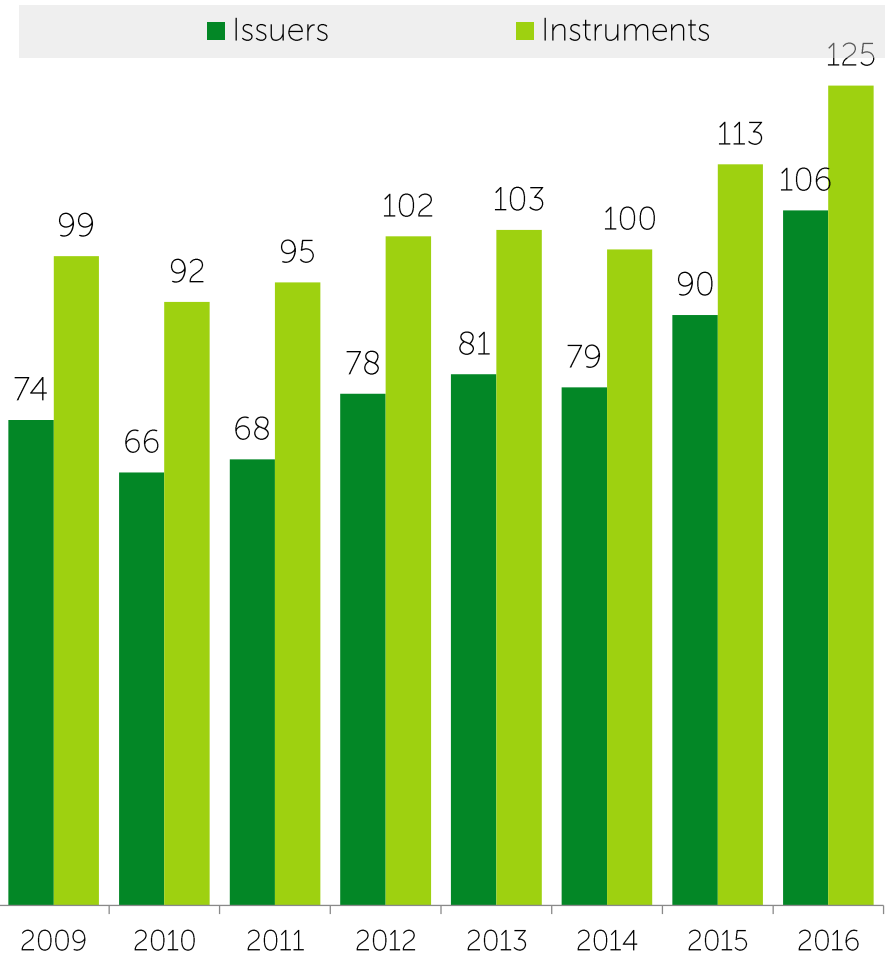
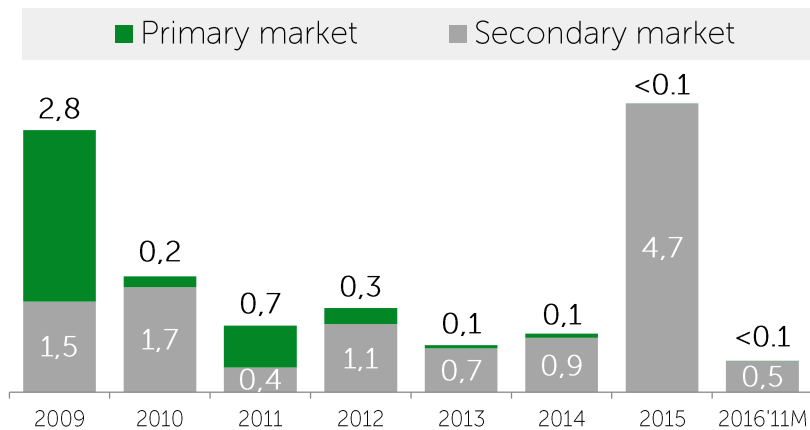

Share Market Capitalization, USD bn

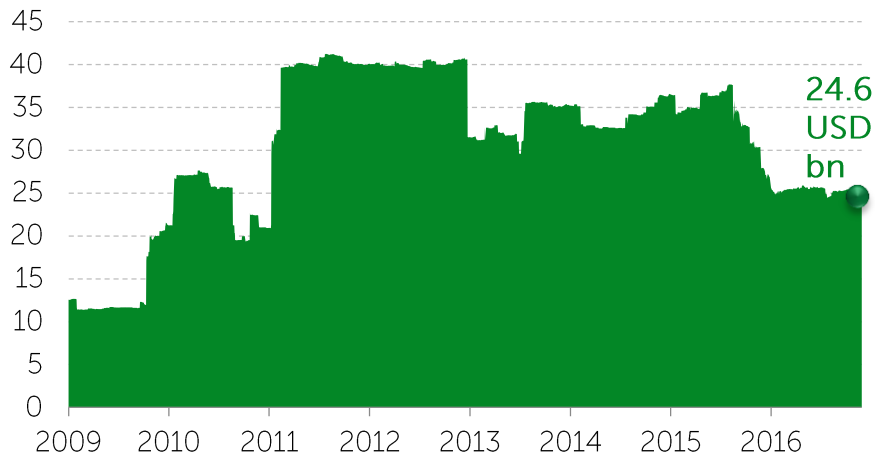


Traded Volume, USD bn

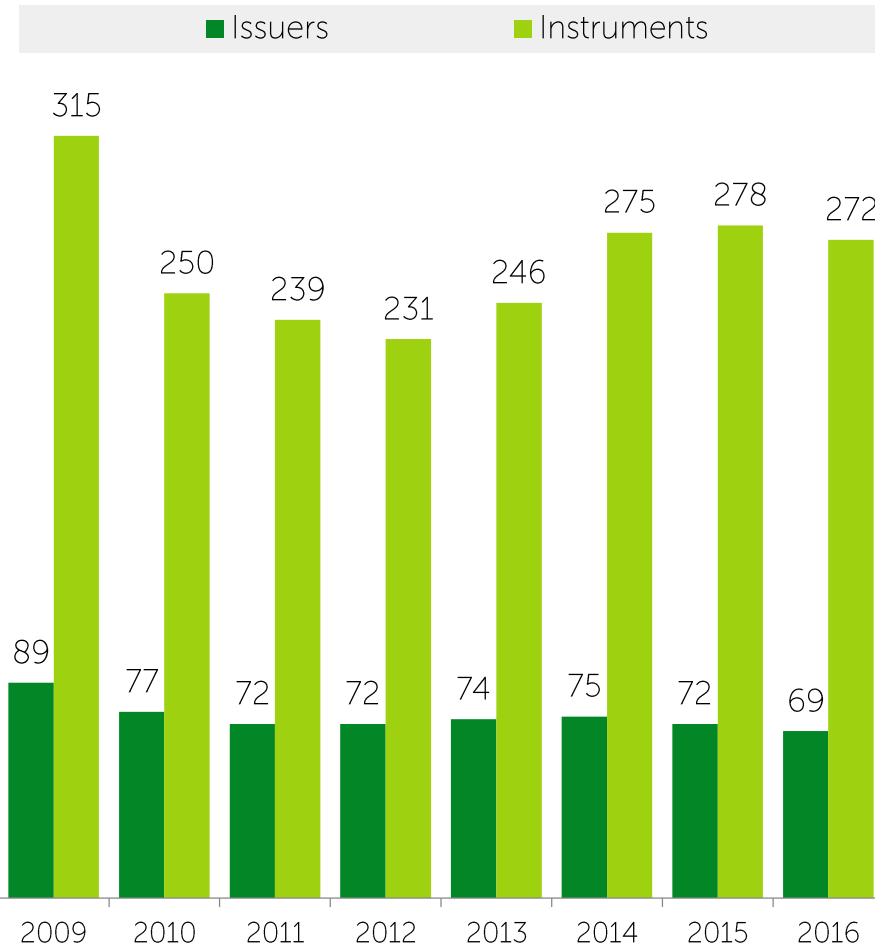


Corporate Bonds Market

Corporate Bonds Market Capitalization, USD bn

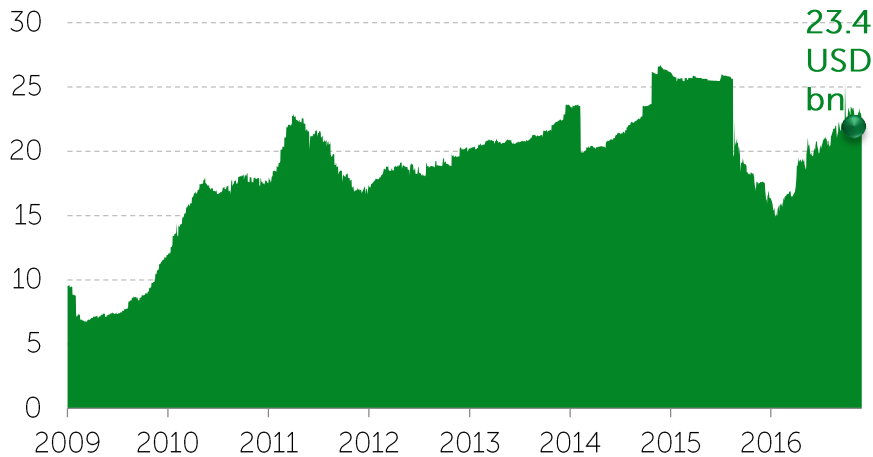

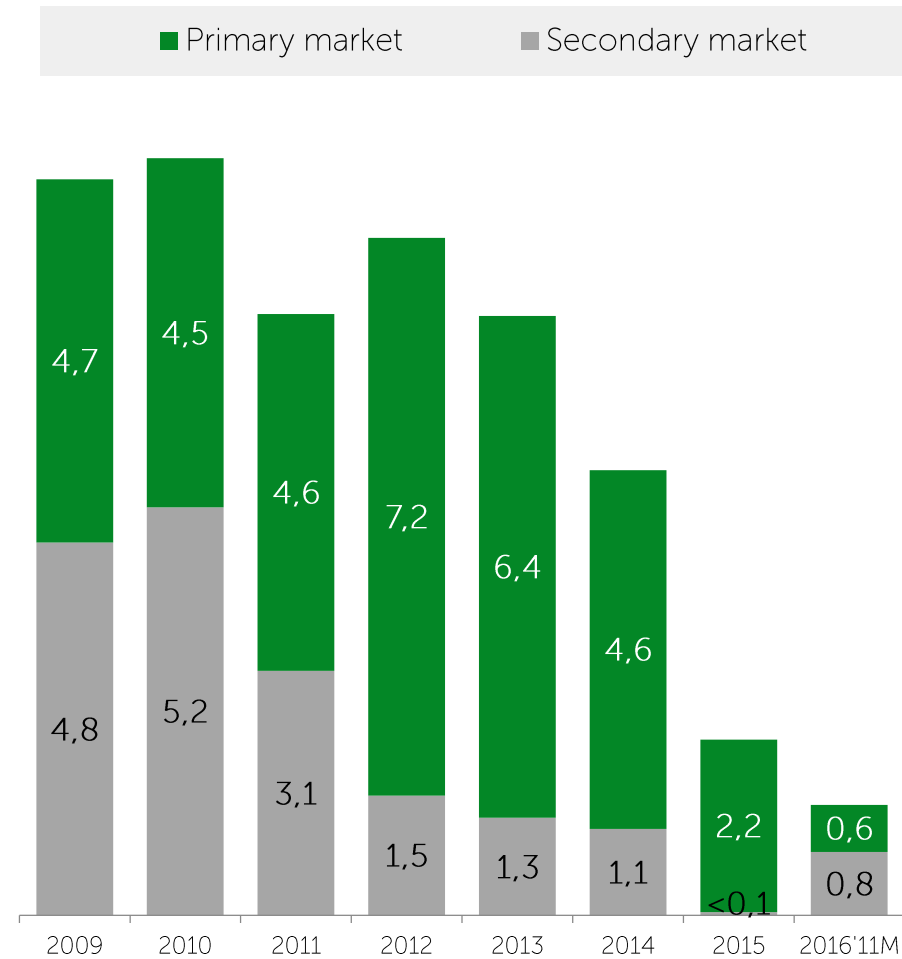


Government Securities Market

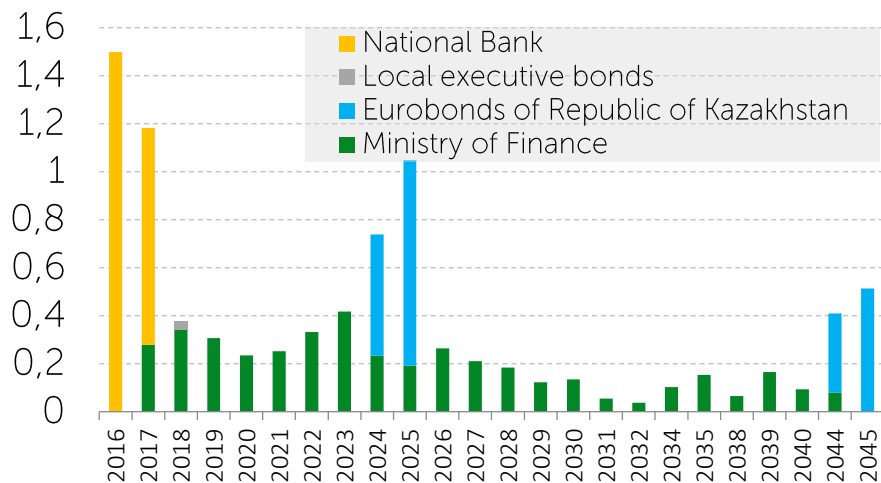
Volume of Public Sector Debt, USD bn

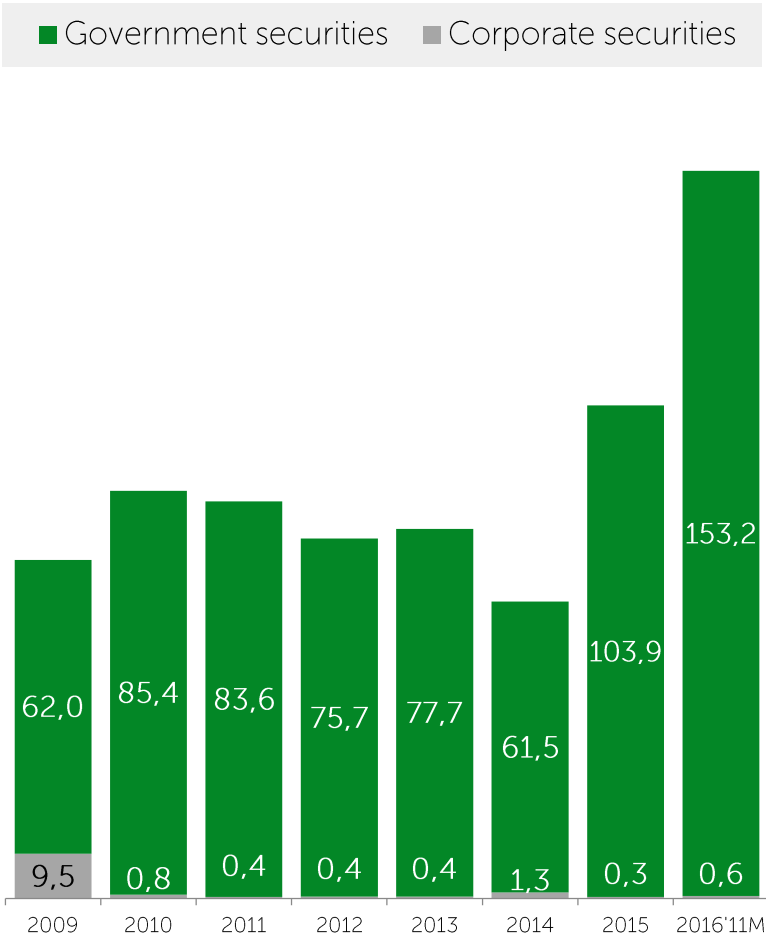
Public Debt Redemption, KZT trln



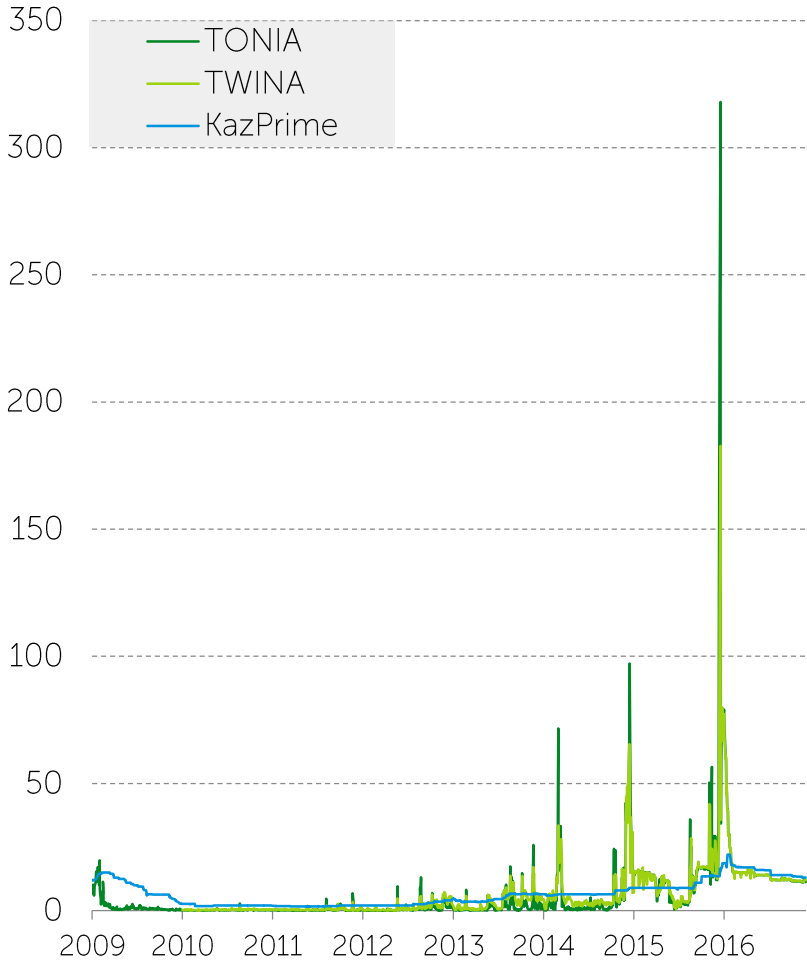
Repo Transactions Market

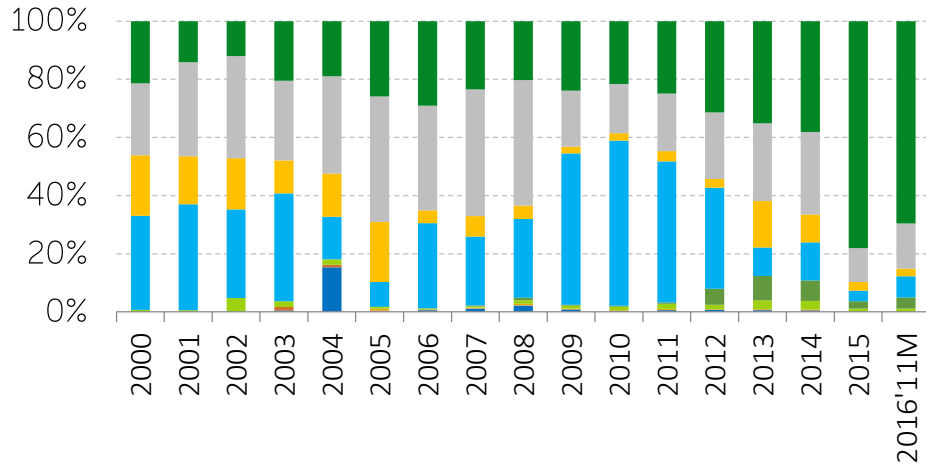


Industry Structure



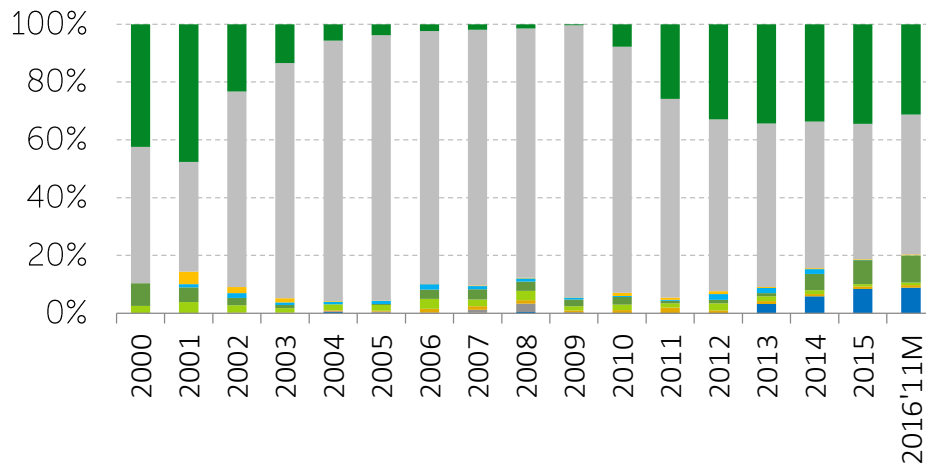

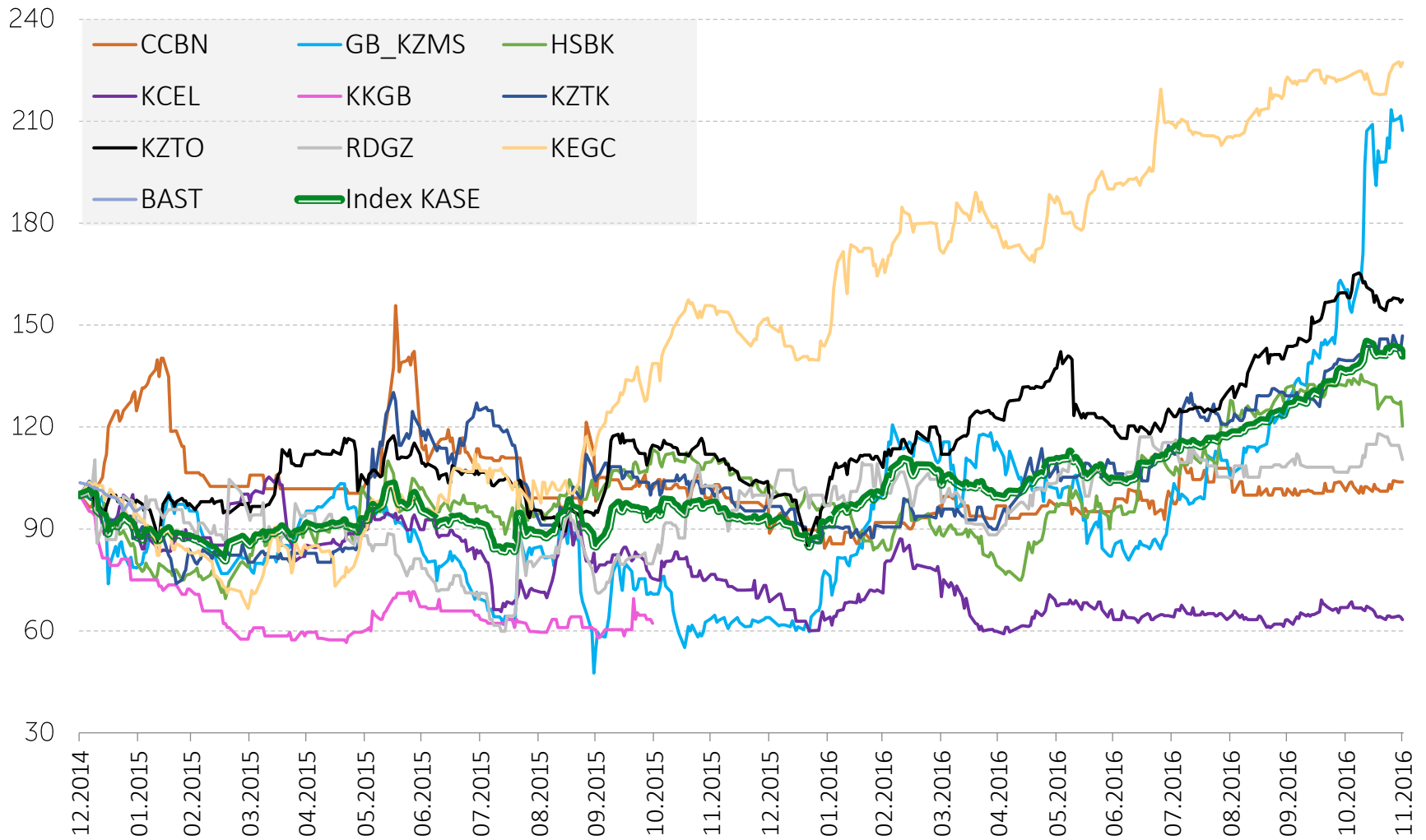
