- ▲ KASE was established on November 17, 1993 under the name Kazakh Inter-bank Currency Exchange – two days after the Tenge (the national currency of Kazakhstan) was introduced
 - ▲ KASE is a commercial organization functioning in organizational-legal form of joint stock companies
 - ▲ KASE has 51 shareholders (as of 01.09.17) – banks, broker-dealer organizations, asset management companies and other financial institutions
 - ▲ Major shareholder: National Bank of Republic of Kazakhstan (50.1 %)







Share Market Capitalization, USD bn



Traded Volume, USD bn








Corporate Bonds Market Capitalization, USD bn









Volume of Public Sector Debt, USD bn





Traded Volume, USD bn



Public Debt Redemption, KZT trln








Sectoral Structure of the Market Turnover
