Kazakhstan oblast) consisting of 3 was purchased at face value KZT100.00 per security (0.03% of authorized capital).

**In CS purchase-sale sector** a total of 54 deals amounting to **\$8,520.0** th or KZT1,328.1 m were made. In comparison with the previous period (47 deals, \$3,182.1 th. or KZT492.2 m) volume of the sector increased 2.7 times as much. Deals were made by 21 KASE's on twenty one instruments twelve of which were bonds. Last week 16 brokers were interested in 23 securities 15 of which were bonds. In the opinion of IRBIS specialists expansion of the market was caused by appearing of new instruments at it.

At corporate bonds market the work with new securities was the main tendency, which has been observed for several week already. Over-purchase of usual market's favorites and, as the consequence, their low yield encourages brokers to work with bonds, which recently appeared in circulation. During two previous weeks participants' attention were paid on bonds of Almaty Kus OJSC, during the analyzed one - Nurbank OJSC (NRBNb1). Precisely these securities were leading at the stock exchange in corporate bonds sector both on number of conducted deals and on their volume as well. As the result of conducting of first six deals yield of NRBNb1 for a purchaser decreased from 9.25% to 9.00% APR. The second place, according to the volume and number of deals, were also new securities – bonds of Kazakhstan Mortgage Company OJSC (KZIKb1), Their forecasted yield continues to fall and has decreased during the week from 9.90% to 9.86% APR. Besides, during 7 days there was decrease at KASE of the yield of BRKZb1 (from 9.82% to 8.44% APR), BTASb2 (from 9.85% to 9.19% APR), KZIKb1 (from 9.90% to 9.86% APR), SMGZb1 (from 17.88% to 16.31% APR), VTPRb1 (from 8.76% to 6.96% APR). The following securities were characterized with increase of yield for a purchaser ASFIb1 (from 10.64% to 11.26% APR), CCBNb1 (from 10.00% to 10.92% APR), KZTOe1 (from 7.30% to 7.40% APR), ORDBb1 (from 11.00% to 11.12% APR), VITAb3 (from 13.00% to 13.05% APR), VTBNb1 (11.32% to 34.17 APR, the last deal was direct). Judging on the data, which is given in the table of stock exchange's financial instruments' investment attractiveness in the beginning of the review, there appears impression of prevailing growth of yield at corporate bonds market. At the same time dynamics of the index KASE BY is the evidence of contrary. Here one should take into account the fact that the index is influenced on not only by the dynamics of quotations and prices, but by changing of representative's list for index calculation as well. During the week euronotes of TuranAlem Finance B.V. (Rotterdam, Kingdom of Netherlands) of the second issue (see below) were included in this list.

On December 11 stock exchange's corporate bonds' capitalization was fixed by KASE on the level of \$1,168.2 m and increased during the week by \$96.6 m that was mainly connected with including of euronotes of TuranAlem Finance B.V. of the second issue (see below) into stock exchange's securities lists since December 6.

At shares market participants' attention again was concentrated in shares of Corporation Kazakhmys OJSC (KZMS). Precisely these securities were leading in the segment according to the number of conducted deals and their volume. In the opinion of IRBIS specialists, activation of the trade was caused by announcing of the date of trades opening on selling the company's SBS, and also approaching meeting of shareholders of Corporation Kazakhmys OJSC, which is to be held on December 14 and during which very important questions will be discussed (increasing of the company's authorized capital from 2.5 to 14 bn tenge and changing of the issue's structure, at which minimal cost of one share may significantly grow). An important circumstance is also the fact that rate of KZMS is very high now. According to results of the week these shares' market capitalization rose by 41.4% to KZT12,300.00 per security. It attracts minor shareholders, who are worrying that in case of increase of share's face value they will have to pay much money in order to keep the securities, which they have. Lately physical persons, who wish to sell their shares more and more often address to the stock exchange. Brokers also say about increased offer. This all causes activation of trade on KZMS. However, despite obvious increase of offer, rate of KZMS continues to grow. Shares' weighted average price in December at KASE reached KZT12,121.97 or USD78.01.

Prices of other shares varied in different ways. Price of ALKSp3 fell by 51.4%, BTAS – by 19.5%, CSBN and CSBNp – by 11.1%, TEBN – by 47.0%. At the same time rate of CCBN rose by 1.5%, KKGB – by 21.0%. On CHFM the first deal was made at KZT90.5 per a security. Main influence upon shares market's capitalization, which increased within 7 days by \$103.2 m to **\$1,418.8 m** (KZT221.2 bn), was made by growth of price of KKGB and KZMS.

In the repo sector of CS 15 deals were made in the total amount of \$3,753.8 th. (KZT583.8 m). 10 deals out of them (in the amount of \$3,194.9 th) repo opening and 5 deals (in the amount of \$558.9 th.) – repo closing. Last week volume of deals in this sector amounted to \$5,606.7 th. (KZT867.7 m).

In all CS trade floors of KASE (including SBS sale sector and primary floatation) a total of 75 deals amounting to \$12,273.9 th. (KZT1,911.9 m) were concluded within the analyzed period. Last period volume of 72 deals did not exceed \$8,788.8 th. (KZT1,359.9 m).

## Changes in trade lists

By the decision of KASE's Board dated December 5 of 2002 **euronotes of TuranAlem Finance B.V.** of the second issue (XS0148572901, \$100 m, May 29, 02 – May 29, 07, semi-annual coupon 10.0% APR), which were issued on the security of Bank TuranAlem OJSC (Almaty), were recognized as included into KASE's official "A" listing category. The decision took effect since October 29 of 2002. At KASE bonds were assigned trade code BTASe2. Quotation accuracy in stock exchange's trade system is four decimal figures of bond's clean price, which is expressed as percentage of debt's face value. Trades at KASe have been opened since December 6 of 2002. Market-maker's status on the mentioned bonds at KASE, on the basis of submitted application, has been assigned to TuranAlem Securities LLP (Almaty). Minimal volume of compulsory quotation for the market-maker is 10,000 US dollar in the debt's nominal expression.

By the decision of Kazakhstan stock exchange's (KASE) Board since December 12 of 2002 trades on selling state block of shares (SBS) of KHIMFARM OJSC (Shymkent) consisting of 1,215,556 common inscribed shares (KZ1C20622113; 23.17% of the issued and paid authorized capital) will be opened at KASE. The decision has been made on the basis of publication of information of the Committee of state property and privatization under the Ministry of finance of Kazakhstan about selling the SBS at stock exchange's trades in accordance with KASE's internal document "State blocks of shares. Order of admission to the sale at trades and settlements according of results of trades". By the decision of KASE's Board this SBS has been assigned trade code Z\_CHMF. According to the documents, which were presented to KASE, announced and issued (paid) authorized capital of KHIMFARM OJSC as of December 10 of 2002 was equal to KZT1,557,675,009.00. Share's face value is KZT297.00. Primary activity of KHIMFARM OJSC – production of pharmaceutical preparations for medical usage.

#### **SECTOR OF GOVERNMENT SECURITIES (GS)**

**In GS purchase and sale sector** of KASE (including euronotes of Kazakhstan) a total volume of 85 deals reached **KZT7,238.1 m** (\$46,471.8 th.). Corresponding figure of the previous week – KZT15,252.6 m (\$98.491.2 th.). Nothing principally new has occurred in the sector, except volume of transactions, and it mainly depend on conducting of non-market, according to nature, deals with euronotes of Kazakhstan by traders.

During the analyzed period no large deals of this type were fixed, as the result the structure of market's turnover came back to its usual condition. As is seen from the data, which is presented in they table, GS's yield at KASE changed during the described week in different ways regardless of type of bonds.

**In GS repo-transactions sector** 459 deals were made for a total of **KZT95,320.6 m** (including automatic repo sector) during the period. Of this number 235 deals (for KZT48,239.6 m) were repo opening deals and 224 (KZT47,081.0 m) were repo closing deals. Last period transactions volume of this type reached KZT81,889.0 m. After closing of the trades on December 11 total amount of opened at KASE repo reached KZT17,061.6 m. Parameters of automatic repo market are given in the table.

The Committee of state property and privatization of the Ministry of finance of Kazakhstan (Committee) informed today Kazakhstan stock exchange (KASE) with the official letter about the fact that beginning of the trades on selling state block of shares (SBS) of Corporation Kazakhmys OJSC (Zheskazgan) at KASE have been set **for December 27 of this year**. Parameters of the trade are not informed about yet. It is known from former messages that the mentioned SBS consists of 1,210,884 common inscribed shares of Corporation Kazakhmys OJSC with the face value of KZT600.00. This is – 24.65% of the issued (paid) authorized capital of the company. Approximate cost of the block, which has been determined judging on the current prices of the company's shares at KASE, equals to 117 m US dollars. According to results of the conducted open competition on purchasing of broker-dealer services while selling SBS of Corporation Kazakhmys OJSC at KASE, which were published by the Committee in the newspaper "Kazakhstanskaya pravda" on November 26, **Kazakhstan financial company OJSC** (Almaty) was recognized as the winner of the competition.
